

GRANITE STATE HRC MEETING MINUTES 04-03-2012

IN ATTENDANCE: TEDDY SLEATH, CHUCK POAT, MARK ROY, JON POWERS, MICHELE LABRANCHE, REGGIE OUELLETTE, BETSY FOGG

SECRETARY'S REPORT: READ AND ACCEPTED.

TREASURER'S REPORT: ONE NEW MEMBERSHIP THIS YEAR, JAMIE WHYTE. BALANCE IN THE ACCOUNT IS \$4,555.05. ALL CURRENT BILLS PAID, BIRD DEPOSITS ARE MADE. MOTION TO ACCEPT BY CHUCK, SECONDED BY REGGIE.

HELDA REPORT: CLEAN UP DATE SAT. APRIL 7 AT 8 AM MEETING AT THE PAVILLION. WILL STAIN THE PAVILLION AND CLEAN UP AROUND BEAVER POND AND DYKE. WORKERS MUST BRING EYE PROTECTION, EAR PROTECTION AND GLOVES. ANY POWER TOOLS THE OPERATOR MUST HAVE CHAPS AND APPROPRIATE EQUIPMENT.

MEMBERSHIP: WE DO NOT LIKE THE FACT THAT PEOPLE ARE DROPPED FROM THE EMAIL LIST IF THEIR DUES ARE NOT PAID.
